### **AGREEMENT, WAIVER AND RELEASE OF LIABILITY**

I release, and hold harmless any claim or and liability by, or asserted against, Arizona Quail Services, Gary French, and all agents and affiliates, to be collectively referred to hereon as “AQS”.

I am a participant in a guided expedition. I understand and acknowledge that my participation in any expedition with AQS involves foreseen and unforeseen risk of illness, injury, or even death to myself and/or my dependents participation in this activity. I also understand and acknowledge that there is risk of damage or loss to my personal property.

These risks include, but are not limited to, forces of nature, actions and/or negligence of others, voluntary and involuntary interaction with domestic animals and wildlife and the inherent risk associated with involvement with firearms.

I attest that any dependents accompanying me, in addition to myself, is of sound physical condition and capable of strenuous activity.

I agree and affirm that any minors accompanying me on this expedition are my natural or adopted children, and that I am the legal guardian. I further give and extend this release and discharge for, and on behalf of all such minor children. I attest that I am empowered to make this release on their behalf.

**I acknowledge that I have received and read a copy of safe gun handling practices. I understand safe gun handling practices and will adhere to these rules at all times.**

In the unfortunate event that I injure or kill any dogs or other animal, belonging to, or in the care, custody, or control of AQS, I shall take full responsibility for any and all medical, veterinary or rehabilitative costs associated with the injuries. In the even of the death of an animal or dog, I shall be directly and immediately responsible for the full replacement value of the dog or animal. This agreement shall be interpreted according to the laws of Arizona. Any disputes arising out of this agreement shall be exclusively under the jurisdiction of the courts of the State of Arizona. If any portion of this agreement is determined by the court to be unenforceable, or void for any reason, the remaining portions of this agreement shall still remain valid and binding upon the parties.
